



Vancouver Sports Club COVID-19 Waiver and Release

PLEASE READ CAREFULLY, THIS AGREEMENT MAY AFFECT YOUR LEGAL RIGHTS

As the parent/guardian of the athlete, I hereby grant permission for _____ (the "Athlete") to participate in Vancouver Sports Club basketball training and related activities (the "Activities"). For the purposes of this Waiver and Release, "Vancouver Sports Club" includes Vancouver Sports Club and its coaches, officials, agents, and/or employees, volunteers, other participants, sponsoring agencies, advertisers, and, if applicable, owners and lessors of premises on which the Activities are held.

I understand that Vancouver Sports Club will not permit the Athlete to participate in the Activities unless and until this Agreement is signed by the Athlete's Parent/Guardian. In consideration of permitting the Athlete to participate in the Activities, I acknowledge and agree to the following terms:

1. ACKNOWLEDGMENT AND ASSUMPTION OF RISKS

- I understand that the Athlete's participation in Activities offered and sanctioned by Vancouver Sports Club may expose the Athlete to some risks including but not limited to significant injury, illness, disability, personal property damage and death.
- I further understand that one of the risks associated with the Athlete's participation in the Activities is transmission and contraction of COVID-19. I understand that COVID-19 is a significant health risk and carries a high risk of transmission through physical or shared contact as well as through close proximity to others. I further understand that, due to the inherent nature of the Activities, by participating in the Activities the Athlete may come into physical or shared contact or close proximity to other Athletes, coaches, staff or other individuals.
- I further understand that, as part of Vancouver Sports Club programs and competitive teams the Activities may include 5 on 5 game play, or other forms of simulated situational practice game play and competitive game play, which may increase the physical or shared contact between the Athlete and other participants.
- I further acknowledge and agree that the Athlete will comply with the recommended guidelines for participation in regards to protection against the transmission of COVID-19. I agree that the Athlete will refrain from participating in the Activities if he/she exhibits any signs of illness including but not limited to fever, cough, running nose, lethargy, shortness of breath, sore throat, nasal congestion, headache, and/or diarrhea, and/or has been in contact with any person known to be infected with COVID-19. In the



case that the Athlete exhibits any of the aforementioned indications of illness or has come into contact with a person known to be infected with COVID-19, the Athlete and/or his/her Parent or Guardian will immediately inform an official at Vancouver Sports Club.

2. WAIVER OF CLAIMS AND RELEASE OF LIABILITY: I, the undersigned Parent/Guardian, hereby agrees as follows:

- I AGREE TO WAIVE any and all claims that the Athlete, I, my executors or administrators, or any other third party may have now or in future against Vancouver Sports Club in connection with the Athlete's attendance at or participation in the Activities.
- I AGREE TO RELEASE Vancouver Sports Club for any loss, damage, expense, personal property damage, illness, injury, disability, death or any other incidence that may be sustained by the Athlete arising out of the Athlete's attendance at and/or participation in the Activities, due to any cause whatsoever, including, but not limited to, those arising out of or involving NEGLIGENCE, breach of statutory duty, breach of contract, mistake and/or fault on the part of Vancouver Sports Club including any failure on the part of Vancouver Sports Club to protect the Athlete from risks associated with the Activities.
- I AGREE TO INDEMNIFY AND HOLD HARMLESS Vancouver Sports Club from any and all damages, loss or expense of any kind resulting from the Athlete's attendance and/or participation in the Activities, due to any cause whatsoever, including, but not limited to, those arising out of or involving NEGLIGENCE, breach of statutory duty, breach of contract, mistake and/or fault on the part of Vancouver Sports Club, including any failure on the part of Vancouver Sports Club to safeguard or protect the Athlete from risks associated with the Activities.

I DECLARE THAT I AM THE ATHLETE'S PARENT OR LEGAL GUARDIAN AND I CONSENT TO THE ATHLETE'S PARTICIPATION AND AGREE TO ALL OF THE ABOVE PROVISIONS AND TO ASSUME ALL OF THE OBLIGATIONS OF THIS RELEASE AND WAIVER ON THE ATHLETE'S BEHALF.

I FURTHER CONFIRM THAT I HAVE READ AND FULLY UNDERSTAND ALL OF THE PROVISIONS OF THIS RELEASE AND WAIVER AND THAT I HAVE GIVEN UP SUBSTANTIAL LEGAL RIGHTS BY SIGNING IT. I FURTHER CONFIRM THAT I UNDERSTAND THAT THIS RELEASE AND WAIVER IS BINDING ON ME, MY EXECUTORS AND ADMINISTRATORS.
